# President's Report:

Well, 2009 what can I say, but WOW!!

With 2009 designated as The International Year of Astronomy by the U.N, astronomy societies world wide were run off their feet, MAS was no exception.

Our main focus was placed on holding Open Nights at The Campbelltown Rotary Observatory. This was held in conjunction with UWS's assistance (Dr Ragbir Bhatal & Mr Mark Johnston). We had approximately 20 – 25 members (with equipment) attend each outing. I would estimate that we had 1200 – 1500 members of the public attend these nights over the year. The feedback I received from the public through various forums was of "wonder and excitement" and a big thank you to the members for their time, knowledge and enthusiasm shown.

We also took our "show" on the road, in April we took part in co celebrations with The Historic Societies of Campbelltown and The Oaks. Starting off with a day long setup of scopes at "Glenalvon" in Campbelltown. Our resident golden tonsils, Bob Bee gave two talks on astronomy and was met with a full house both times. Late afternoon, we set off for The Oaks for our next session with The Oaks society. Bob backed up to give another presentation, with the crowd primed for astronomy, they were released into the court yard to be greeted by 20 astronomers keen to show them "What was out there".

In June we visited Tudor House at Moss Vale, we were welcomed with a hot dinner and a group of very enthusiastic children. Bob Bee again entertained the children first, but when it became our turn with the telescopes......all we could show them was a cloudy sky. It was very disappointing for all involved......but they have asked us to return this year!!

At the end of June, we travelled to Cawdor Public School for an observing night, Bob as usual wowed all in attendance with his presentation, when it came time for telescope viewing the sky was clear! We kept a group of 40 children, parents and teachers enthralled with the images of the night sky for the following hour.

Our next outing was at The Wollondilly Anglican College at Tahmoor. Dave Reneke (Sky & Space Mag) gave a presentation on Astronomy to the Students. He asked if we could supplement the talk with telescopes. we again supplied 10 scopes. After David's talk, we were swamped by approx 60 eager novice astronomers keen to put into practice what they had learned.

# Prof Fred Watson

Was our Keynote speaker of the year. In September he was greeted by over 100 members of the Public at the new Medical Facilities buildings at UWS Campbelltown.

His presentation was on "Why is Uranus Upside down?" After a successful evening, I took Fred up to the Observatory where we were greeted by a plethora of MAS astronomers, all manning their scopes with an ever inquisitive (and ever growing) "public" presence. Thanks Fred!!.

These procedures have been undertaken to form an opinion whether, in all material respects, the financial statements are presented fairly in accordance with accounting standards and other mandatory professional reporting requirements so as to present

a view which is consistent with my understanding of the Astronomical Society's financial position and the results of its operation. The audit opinion expressed has been formed on the above basis. **Note 1 - Accounting principles and methods adopted in accounts** 

The accounts have been prepared on the cash basis, and in accordance with applicable statements of accounting concepts and accounting standards issued by the Australian Accounting Standards Board (AASB). They have also been prepared on the basis of historical costs. The accounting policies have been consistently applied unless otherwise stated.
