At the beginning of 2009 a new fee structure was put into place by I.H.

**Independent Audit Report**

I have audited the financial statements, being the statement of financial position and statement of financial performance. The Astronomical Society Committee is responsible for the financial statements. The audit has been conducted in accordance with the Australian Auditing Standards to provide reasonable assurance whether the financial statements are free of material misstatement. My procedures including examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial statements and the evaluation of accounting policies and significant accounting estimates. These procedures have been undertaken to form an opinion whether, in all material respects, the financial statements are presented fairly in accordance with accounting standards and other mandatory professional reporting requirements so as to present a view which is consistent with my understanding of the Astronomical Society's financial position and the results of its operation. The audit opinion expressed has been formed on the above basis.

**Note 1 - Accounting principles and methods adopted in accounts**

The accounts have been prepared on the cash basis, and in accordance with applicable statements of accounting concepts and accounting standards issued by the Australian Accounting Standards Board (AASB). They have also been prepared on the basis of historical costs. The accounting policies have been consistently applied unless otherwise stated.

**Note 2 - Non-Current Assets**


Non-Current assets are included at cost or at independent valuation. All non-current assets are depreciated over their estimated useful lives commencing from the time the asset is held ready for use.
