Online conference meeting Monday 3rd July 2023 at 7.00 pm

1 OPENING OF MEETING

The Zoom meeting opened at 7.07 pm.

2 MINUTES OF PREVIOUS MEETING

2.1 ACCEPTANCE OF MINUTES DATED 5th JUNE 2023

Motion: That the Minutes dated 5th June 2023, as circulated and posted, be accepted.

3 REGULAR BUSINESS

3.1 TREASURER'S REPORT

3.1.1 Financial status

During the month \$3701.17 was transferred from the main account to the deposit account. One new member paid \$60.50, \$90.00 was received re Wooglemai and \$34.00 merchandise for the sale of the last star wheel. \$90.00 is payable to Wooglemai.

Interest received for the month on deposit was \$21.71.

PayPal - Two payments were made via PayPal; \$6.40 postage costs for the star-wheel, and Zoom \$24.63. A transfer of about \$1,162 from the PayPal account to the main account was agreed.

23/24 Budget will be prepared for the July meeting.

3.1.2 Term Deposit

As approved at the previous meeting, the rolling monthly low interest term deposit was terminated in June. A new Commonwealth Bank term deposit of 12 months duration was opened, at 3.95% pa for the amount of \$25,000. The account will accrue interest after six and twelve months.

3.1.3 Publishing account details on website for logged on members

It was agreed that the MAS working account number and BSB can be published on the website to enable prospective members to join and current members to renew, without needing to ask for bank details.

3.1.4 Bank Account Access

NS advised that the Commonwealth Bank require a formal motion to add a person as a signatory. The motion format was supplied to him by the Bank:

<u>Motion</u>: That the committee of Macarthur Astronomical Society hereby authorise Dave Manning in his capacity of Membership Officer to be added to the Society's Commonwealth Bank account authority as an additional signatory to the working account only. The committee also reaffirmed that the method of operation is to be maintained at two signatories required per transaction.
